## **Who will control my data?**

The data controller/processor for all the information you provide is the Cornish Pilot Gig Association (CPGA) CIO.

## **How will we use the information about you?**

The information that you provide for Club Contacts will form the basis of a club contact Document.

The information that you provide for your Club Membership Register (where applicable) will be reviewed as necessary.

At CPGA Championship events, membership will be checked via the Just Go platform. The information that you provide in your Club Membership Register will be data analysed and shared with appropriate bodies e.g. working partners, in an anonymous format.

This information is required in order for the CPGA to act as a governing body.

## **Who else will we share your information with?**

Club Contacts – these will be shared with CPGA club contacts only – please see CPGA club List.

Club Membership Registers – in an anonymous format eg removal of names/DOB with working partners as appropriate. Please note that club names will appear alongside anonymous data for individuals, where appropriate.

## **How will we look after your data?**

Your data will be held within a secure network. It will not be processed outside of the UK / the EEA.

Access to your information will only be made by authorised CPGA staff or CPGA trustees who are required to process it for the purposes outlined in this privacy notice.

## **How long will you keep this information for?**

Club Contacts will be held until there is a change notified to the CPGA.

Club Membership Registers will be held for eighteen months (18) from the 1st January each year. As these registers are electronic, all will be deleted from the files. Anonymous data will be held indefinitely.

## **What are your data rights?**

Your personal information belongs to you and you have the right to:

- Be informed of how it will be processed
- Request a copy of what we hold about you and in commonly used electronic format if you wish (if you provide this to us electronically for automated processing we will return it in the same way)
- Have it amended if it's incorrect or incomplete
- Have it deleted (where we do not have a legal requirement to retain it)
- Information will not be deleted where it is in the legitimate interests to retain the data for the benefit of governance of the CPGA.
- Withdraw your consent if you no longer wish us to process – please bear in mind this has implications for the CPGA in not being fully informed regarding the population of the membership
- Restrict how we process it
- Object to us using it for marketing or research purposes
- Object to us using it in relation to a legal task or in the exercise of an official authority
